This Limited Warranty is for the sole benefit of the Purchaser named herein and applies only to **System** applied to the **Vehicle** described above.

This certifies that the Anti-Theft ID System has been installed on the vehicle listed above. In the event that the system fails and the vehicle is stolen and; 1)not recovered within thirty (30) days after the **Date of Loss**, and 2) the **Vehicle** is deemed a Total Loss by **Your** comprehensive insurance company, then subject to all the terms and conditions of this Limited Warranty, **We** will pay **You** up to Benefit Amount shown above.

There are no warranties which extend beyond the description herein. We are not liable or responsible for any incidental, consequential, commercial, or exemplary losses or damages. Some states do not allow limitations on implied warranties or the exclusion of incidental or consequential damages, so the above limitations may not apply to **You**. This Limited Warranty gives **You** specific legal rights, but **You** may also have other rights that vary from state to state. The purchase price of the **System** is **NON-REFUNDABLE**.

None of **Our** representatives, employees, dealers or agents is authorized to alter, extend, amend or modify the terms of this Limited Warranty. By **Your** signature below, **You** acknowledge that **You** have read this Limited Warranty including the terms, conditions, exclusions, and claim procedure printed on the reverse side of this document. Purchase of the **System** is not required in order to purchase, lease or obtain financing for the **Vehicle**.

DEFINITIONS

Dealer: The **Dealer** shown on this page of this Limited Warranty, who installed the **System** to **Your Vehicle**.

Date of Loss: The date the theft was reported to the appropriate law enforcement agency.

System: The Anti-Theft ID System.

Term: The amount of time that this Limited Warranty shall be in force as shown on this page of this Limited Warranty. The **Term** begins on the **Purchase Date** and expires on the **Expiration Date**.

Expiration Date: The **Purchase Date** plus the **Term**. This Limited Warranty expires at 12:01 a.m. on the **Expiration Date**.

Purchase Date: The date the **Vehicle** was sold to **You**.

Vehicle: Means the **Vehicle** described on this page of this Limited Warranty.

We, Us, Our: Quantum-Shield, Inc. is the Administrator and the Warrantor under this Limited Warranty.

You, Your: The person named on this page of this Limited Warranty as the Purchaser.

Our obligations under this Limited Warranty are guaranteed solely by Equity Bay Reinsurance, Ltd. Upon **Our** failure to pay any covered claim within sixty (60) days after submission of complete proof-of-loss documents, **You** may make a direct claim with Equity Bay Reinsurance, Ltd.

GENERAL PROVISIONS

1. Payment made under this Limited Warranty is limited to the difference between the N.A.D.A. actual cash value of the stolen vehicle and the vehicle's replacement cost. The maximum amount payable under this Limited Warranty shall not exceed fifty percent (50%) of the N.A.D.A. actual cash value of the **Vehicle** at **Date of Loss** and the **Vehicle's** replacement cost or the Benefit Amount, whichever is less.
2. In the event that any window or body panel of the **Vehicle** is replaced, **You** must contact **Us** within fifteen (15) days of such replacement to arrange for the replacement window(s) or panel(s) to be affixed with the **System** DNA code. Failure to do so voids this Limited Warranty in its entirety as of the date such replacement was made. Affixing the **System** DNA code to replacement windows or panels does not extend the term of this Limited Warranty.
3. This Limited Warranty may be transferred if the **Vehicle** is sold to a new owner other than an automobile dealer. In order to effect transfer, the transferor must provide **Us** with a copy of the bill of sale (clearly identifying the new owner's name and address) and a transfer fee of thirty five dollars (\$35.00) made payable to Quantum-Shield, Inc., within fifteen (15) days of the **Vehicle** sale.
4. As the **System** is permanently installed on the **Vehicle**, the purchase price of the **System** is/are **NON-REFUNDABLE**.
5. Failure to have or maintain comprehensive vehicle insurance coverage on the **Vehicle** voids this Limited Warranty in its entirety.

SPECIAL STATE DISCLOSURES AND REQUIREMENTS

Ohio - This vehicle protection product warranty is not subject to the insurance laws of this state, contained in Title XXXIX of the Ohio Revised Code. This warranty may not include all of the benefits or protections of an insurance policy that includes theft coverage issued by an insurer.

EXCLUSIONS

This Limited Warranty shall not apply to:

1. Loss or damage not covered by **Your** primary comprehensive insurance carrier.
2. Claims which are not reported within seven (7) days following the occurrence of loss of the **Vehicle**.
3. Incidental or consequential expense(s) such as loss of time or use, inconvenience, commercial loss, personal injury or property damage.
4. Loss or damage resulting from theft by **Your** family member(s) or any other person who had access to the keys of the **Vehicle**.
5. Loss occurring if the **Vehicle** was left unlocked or if the keys were left in the Vehicle.
6. Loss or damage due to war, whether or not declared, invasion, civil war, civil commotion or riot, insurrection, rebellion or revolution, nuclear reaction, nuclear radiation or radioactive contamination, earthquake, explosion, falling objects, fire, smoke, flood, or acts of God.
7. Loss or damage by **You** resulting directly or indirectly from forgery or any dishonest, fraudulent or criminal act, or due to conversion, embezzlement or by any person in lawful possession of the **Vehicle**.
8. Loss occurring after the expiration of the **Term** of this Limited Warranty.
9. Loss due to failure resulting from normal wear and tear.
10. Loss which occurs outside of the United States or Canada.

HOW TO FILE A CLAIM

1. Within seven (7) days of the occurrence of the Loss of the **Vehicle**, **You** must call the Claim Department at **800-287-1608** to open a claim file.
2. Within thirty (30) days of settlement by **Your** primary insurance carrier, **You** must submit the following legible documents to **Us** at 2328 E. Lincoln Highway, Suite 103, New Lenox, IL 60451:
 - A. Copy of this Limited Warranty;
 - B. Copy of **Your** insurance policy Declaration Page, clearly identifying the Vehicle and specifying insurance coverage;
 - C. Copy of **Your** insurance company's claim settlement check(s) showing final payment; and
 - D. Copy of the police report.
